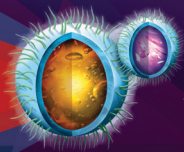

**ECOTOXICITY**

**PRECAUTIONS**

 When mixing and applying wear protective clothing such as goggles, waterproof gloves, cotton overalls and boots. Wash hands and exposed skin before eating, drinking and after work. Wash gloves and protective clothing daily.

**DIRECTIONS FOR USE:**

Commercial, industrial and residential premises including hospitals, hotels, and food handling premises.	Cockroaches, stored product insects, flies and ants.	50 mL per 5 L per 100 sq m treatment area.	Product placement should be at harbours and aggregation areas such as corners, areas of movement or cracks and crevices. Numerous smaller placements will provide faster control than fewer larger spots especially for German cockroach control. Apply to skirting boards, floors and carpets, behind sinks, stoves, and pipes paying particular attention to all cracks and crevices which might contain insects. Apply to all areas where insects are seen, and known harbours.

**MIXING:** Invert the ATTRATHOR container several times to ensure thorough mixing of concentrate. Half fill the spray tank with water and then add the required quantity of ATTRATHOR. Stir and then top up the spray tank to the required volume. The use of this product in a tank mix with other insecticides is not recommended as the behaviour and efficacy of the product is likely to be affected. Ensure equipment is clean.

**GENERAL INSTRUCTIONS:** ATTRATHOR Targeted Insecticide is recommended for use as a targeted indoor crack and crevice treatment. This substance must be under the personal control of an approved handler when it is

- applied in a wide dispersive manner; or
- used by a commercial contractor.

**STORAGE AND DISPOSAL:** Store in the closed, original container in a cool, well-ventilated area. Do NOT store for prolonged periods in direct sunlight. Triple or (preferably) pressure rinse containers before disposal. Add rinsings to the spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Do not burn empty containers or product.

**FIRST AID:** If swallowed wash out mouth with water.

Do NOT induce vomiting. Contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. If skin or hair contact occurs, flush with clear running water for at least 15 minutes. If inhaled remove patient to fresh air.
